Description

1. The Tarlac State University, through Special Budget (SB) Fund intends to apply the sum of One Million One Hundred Ninety-Four Thousand Seven Hundred Ninety Pesos (₱ 1,194,790.00) to payments under the contracts for the project: Supply and Delivery of Medical and Dental Supplies (APP 2025 – 1st Quarter), Rebid.

Bids received in excess of the ABC for shall be automatically rejected at bid opening.

2. The Tarlac State University now invites bids for the project Supply and Delivery of Medical and Dental Supplies (APP 2025 – 1st Quarter), Rebid. Delivery of the Goods is required within forty-five (45) calendar days from the receipt of the Notice to Proceed. Bidders must have completed, within the last five (5) years prior to the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

6. The Tarlac State University will hold a Pre-Bid Conference on May 23, 2025 (2:00 P.M.) at the Bids and Awards Committee Conference Room, 3rd Floor, Motorpool and Administration Building, Tarlac State University, Romulo Blvd., San Vicente, Tarlac City, which shall be open to prospective bidders.

Three (3) copies of the bid proposals (one original, and additional copy 1 and 2) must be submitted to the BAC which must be duly received by the BAC Secretariat through manual submission at the office address indicated in the bidding documents, on June 4, 2025 at 1:30 P.M. Failure of bidders to comply with the said request of additional copies shall not be a ground for disqualification.

Late submission shall not be accepted.
